Sir/Madam,

This has reference to your online application bearing registration no. EX-02156-2021 on the above subject and the subsequent report received from the inspection committee, constituted for the purpose of periodical inspection of the school.

In this regard, the following deficiencies / requirements have been observed for compliance. The School is required to submit the compliance of the deficiencies / requirements.

1. The school has submitted the copy of Recognition Certificate dated 17.03.2001 which is already expired. The school is directed to apply for Recognition Certificate immediately and submit the same to the Board within a period of one year on issuance of grant letter
2. The school is required to submit the copy of Compact Land Certificate of Land (as per Appendix VI of affiliation Bye-Laws of the Board) duly certified by Competent Authority i.e. Sub Registrar/ Tehsildar/ District Magistrate etc. to the board as per the boards' norms.
3. The school is required to submit the DEO (District Education Office) Certificate as per Appendix-III of the Affiliation Bye Laws of the Board.
4. The school is required to submit notarized affidavit to the effect that the school is not sponsoring students from the Board and no member is related to each other in School Management Committee. Hence, the school is required to submit the same.

However regularization of affiliation from 01.04.2020 for a period of 05 years will be subject to the specific compliance on the discrepancies communicated by the School at the earliest not later than 30 days of issue of this letter failing which a penalty of Rs.20,000/- per month will be levied on the school and the process of withdrawal of affiliation may also be initiated.

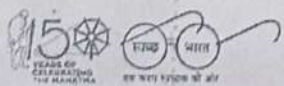

2. The School is required to apply on online for further extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
3. The school will also abide by the conditions prescribed, if any, by the State Government concerned as mentioned in certificate as per appendix III issued by District Education Officer (DEO) /equivalent officer.
4. The school should ensure the strong governance and management of its activities in way of comprehensive and quantifiable planning in way of curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular areas.
5. The school will strictly adhere to all rules regarding safety of students including Fire fighting and Transportation, etc. Further, school will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students.
6.
